- Pastor Sarah Stadler-Ammon, Grace Lutheran Church.
 - Pastor Sarah welcomed guests to the campus of Grace Lutheran Church. She spoke of the congregation's service to the community, including: feeding the hungry, providing heat relief shelter, a clothing/hygiene closet, a family planning clinic, and a mentoring program. Community partnerships are a key strategy for serving those in their community.

- Arizona Impact Summit – solutions for the common good.
 - Jessica and Ben spoke about this event on April 23, 2012 at ASU in Tempe. The Council of Religious Advisors (CORA), ASU and our Council are the lead entities for delivering this one day Summit. A plenary “by invitation only” for 350 leaders will be followed by many topical breakout sessions. Two keynote speakers for the plenary have been identified: Lattie Coor, former ASU President; and Clarence Carter, Director of DES. We are looking for a Federal Government speaker, perhaps connected with the White House Office of Faith-Based and Neighborhood Partnerships.
